#### **Program Overview**

The Health-System Pharmacy Administration and Leadership Residency is a 24-month program. There are two positions: one based at M Health Fairview University of Minnesota Medical Center (UMMC) and one based at Fairview Pharmacy Services (FPS). This program fulfills the requirements of a PGY1 Pharmacy Residency and a PGY2 Residency in Pharmacy Administration and Leadership.
