Plain Language Summary

What if I can't pay for my medical bills?

We offer two programs to help our patients pay their medical bills: *Charity Care* and *Senior Partners*. These programs cover charges for many services in our clinics and hospitals.

What is Charity Care?

- This program is available to Minnesota and Wisconsin residents.
- You may qualify for free or discounted care based on your household income and assets (like a house or car). Your income may be up to four times (400%) the Federal Poverty Level.
- **Covers:** Emergency and medically needed care, as well as all retro accounts
- **Does not cover:** Out-of-network services (based on your insurance) or care from a M Health Fairview doctor
- Once approved, Charity Care is effective for 6 months

What else do I need to know?

- Fairview is in compliance with state regulatory requirements and Federal Debt Collection Practices Act (FDCPA) guidelines.
- Fairview is in compliance with the Minnesota Attorney General (AG) Agreement and 501r. This includes patient friendly billing, payment options and appropriate time for patients to pay their bills, including interest free payment plans and charity care prior to pursuing Extraordinary Collection Activity (ECA).
