Program Overview

The post-graduate year two (PGY2) Psychiatric Pharmacy Residency is a 12-month program located at M Health Fairview University of Minnesota Medical Center, West Bank Campus. This program prepares the resident to become a psychiatric clinical pharmacist through a breadth of advanced psychiatric-focused core and elective learning experiences.

M Health Fairview University of Minnesota Medical Center is the largest mental health provider in the upper Midwest with 13 inpatient psychiatry units and over 200 psychiatry beds. Treating patients of all ages and psychiatric conditions ranging from child and adolescent to senior psychiatric care, M Health Fairview University of Minnesota Medical Center is a national leader in research and treatment of mental illness. M Health Fairview University of Minnesota Medical Center is a teaching hospital for the University of Minnesota Medical School and College of Pharmacy. The PGY2 Psychiatric Pharmacy Residency will allow the resident to develop the psychopharmacology, clinical judgment and problem solving, communication, collaboration and teaching skills necessary to excel as an independent clinical psychiatric pharmacist.

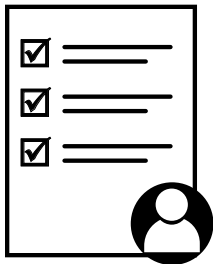
